ACKNOWLEDGEMENT AND ASSUMPTION OF RISK AND RESPONSIBILITY: I recognize the inherent risks of the sport of fencing which I, and/or any minor child for whom I am responsible, will engage in. I confirm that I am (we are) physically and mentally capable of participating in the activity. I/We participate willingly and voluntarily and I assume full responsibility for personal injury, accidents or illness, and any related expenses. I also assume responsibility for damage to or loss of my/our personal property. I also assume risk for accidents or injury caused by the negligence of other fencers whether such negligence is comparative or contributory. I acknowledge that wearing appropriate clothing and footwear are basic safety precautions.

CONVENANT OF GOOD FAITH: I recognize that you, as a provider of services, will operate under a covenant of good faith and fair dealing, but that you may find it necessary to refuse or terminate, the participation of any person you judge to be incapable of meeting the rigors or requirements of participation in the activity. I accept your right to take such actions for the safety of myself and/or other participants.

AUTHORIZATION: I hereby authorize any medical treatment deemed necessary in the event of any injury or illness while participating in the activity. I either have appropriate insurance or, in its absence, agree to pay all costs of medical services as may be incurred on my/our behalf.

RELEASE: In consideration of the services or property provided, I, for myself and any minor children for which I am parent, legal guardian, or otherwise responsible, any heirs, personal representatives or assigns, do hereby release: **HIGH DESERT FENCING CLUB,** its principals, directors, officers, agents, employees, and volunteers, and each and every land owner, municipal and/or government agency upon whose property an activity is conducted, from all liability and waive any claim for damage arising from any cause whatsoever.

1) signed membership form **2)** signed code of conduct **3)** pay an annual HDFC membership fee of \$25 **4)** pay 1st and last month's dues. **5)** membership in USA FENCING, the national sanctioning body for fencing. Each fencer is required to have a minimum of a \$5 annual Non-Competitive membership. If the fencer wishes to compete in sanctioned events a USA Fencing Competitive membership is required and provides additional benefits.

Daily Drop-in fee: \$12.00 for visitors with own equipment and \$15.00 for visitors who need to use club equipment.
Visitors must sign liability waiver. Visiting A and B rated fencers are gratis but must still sign liability waver.

Private lessons: Fencing Master Michael Gueguen offers 20 minute private lessons. Prepaid 5 lesson punch cards are \$100 or 11 lessons for \$200. You can purchase the lesson punch cards directly from Michael. There is a schedule/ sign up board on the North wall at the end of the strips where you can sign up.

Group lessons: Group lessons are available with Fencing Master Michael Gueguen. There will be a fee based on the size of the group. Availability is based on demand so talk to us if you are interested.

Workshops: We will also host workshops that will offer training and lessons from Master Michael Gueguen and/or visiting coaches. Information on dates, times and fees will be distributed as it becomes available. Let us know if you are interested.

Our fencing year begins August 1st and ends July 31st. The **\$25 annual HDFC membership fee** will be billed in August for continuing members. When members pay dues for June and July there will be no dues charged for August and only the annual fee will be charged. The renewal date for USA FENCING's annual membership is also on August 1st. HDFC Membership period is month to month with a two month minimum which consists of payment of first and last month's dues. Your membership status and level may be changed at any time by submitting notice to the treasurer. **New members are welcome any time.** The first month's dues may be prorated to the starting week of the month. Thereafter dues are due on the first of the month. Dues are past due after the 10th (tenth) of the month. Dues going unpaid after the 20th (twentieth) will automatically apply the prepaid last month's dues to satisfy the delinquency in membership and club privileges will be withdrawn on the last day of the delinquent month. To re-instate membership a new first and last month's dues are required. Withdrawal from the club requires 30 (thirty) days written notice. After notice is given we will apply your prepaid dues to the last month.
